Depending on the type and style of the carriage or wagon the driver reserves the right to limit the amount of occupancy to suit the given vehicle, for your safety and the appropriate space of each vehicle.

Should the customer or his or her guest(s) become ill cause damage, or create an unsafe situation the driver will at his discretion terminate this contract in such case no refund will be made and the customer will become responsible for said damage and any cleanup necessary to correct any given situation.

**LIABILITY FOR DAMAGE/PERSONAL INJURY:** Due to irresponsible behavior of the customer or his or her guest(s) will be born by the customer and the customer should warn all guests, friends, children, that Horses that Draw a carriage (Wagon) are not machines and can be frightened by the use of firecrackers, horns, thrown objects or unruly loud behavior, also balloons or noise makers can frighten a horse.

**RESTRICTIONS:** There is no smoking or drinking permitted in the carriage. It is advised that pregnant women, persons with a heart condition, or physical problems avoid the use of Horse Drawn equipment.

**CANCELLATION:** In the case of inclement weather, the contract may be cancelled by the driver, a full refund, less a \$150.00 booking fee, will be made to the customer, if the horse and vehicle has not arrived at the departure site prior to the inclement weather. In such case as they have arrived and set up the deposit will be forfeited. If in the opinion of the driver the weather is suitable, he will complete the contract. If the customer feels he or she does not want to complete the contract and go on with the event he will forfeit the money as stated. A full refund of your deposit will be made if you cancel six months prior to the stated contract date. There is a remote chance that this contract may be cancelled due to veterinary problems. In such a case full refund will be made to the customer, since these types of problems are out of the control of the contractor he cannot be held liable beyond the refund of your deposit.

**SET UP AREA:** The customer is responsible for providing a suitable setup area for the truck(s), trailer(s) and carriage(s). Preferably with limited access, for the safety of spectators.

**DANGER INVOLVED:** Please bear in mind there are certain risks involved when using horses and carriages (wagons). Animals can sometimes be unpredictable, always use caution when around them and advise your guests to do the same. Make sure that you the customer and his passenger(s) are not in weak physical condition. The customer and his passenger(s) should be physically able to board and unboard the vehicle properly. Make sure children are supervised, and warned of the dangers involved.
